Compartment specific changes made during the Compartment Review

Compartment 060 (Stand Examiner – Richard Barber)

- Stand 4 – Reorganize prescription specification wording. Reduce size of treatment to exclude 1D along the river corridor.
- Stands 65, 67, 80 – Acceptable Regeneration, modify to accept low to medium regeneration.

Compartment 151 (Stand Examiner – Ryan Zimmerman)

- No Changes.

Compartment 161 (Stand Examiner – Ryan Zimmerman)

- Stand 107 – Add trail protection specs.

Compartment 168 (Stand Examiner – Ryan Zimmerman)

- No Changes.

Compartment 002 (Stand Examiner – Dan Natzke)

- Stands 31, 44, 54, 113 – Add prescription on top of burn to plant oak and pine per MNFI recommendations. Add burn as a follow-up step in 7 to 10 years following MNFI recommendations.
- Stands 31, 44, 70, 100 – Add trail protection specs. Note the type of trail.

Compartment 016 (Stand Examiner – Darrick Coy)

- Stand 35 – Add next step of other/other for exclosures.

Compartment 023 (Stand Examiner – Darrick Coy)

- Stands 91, 90, 94 – Add comments to request Archeological survey.
- Correct road mapping on McCormick Lake.
- Stand 39 – Add skips in pesticide use to protect advanced oak regeneration.
- Request RAS to remove misc. map symbols.
- Stands 23, 30, 49, 94 – Update trail title to MCCCT.

Compartment 037 (Stand Examiner – Darrick Coy)

- Contact RAS to remove deer blind point feature from map.
- Contact RAS to only show gates on State managed lands.

Compartment 047 (Stand Examiner – Richard Barber)

- All aspen and oaks stands; correct spec number regarding grouse drumming logs.
- Stands 49, 65, 70 – Add trail protection specs.
- Stand 37 – Update prescription comments regarding shooting range; consider open/closed days, hours, winter harvest, etc. during timber harvest.

Compartment 050 (Stand Examiner – Richard Barber)

- Stands 2, 10, 24, 40, 97, 98 – Correct spec number regarding grouse drumming logs.
- Stand 100 – Remove base layer indicating airport.
- Compartment 049 / Stand 36 – Add treatment while cutting Stand 24 in Compartment 050. Add trail protection specs to Stand 24/Compartment 050, and Stand 36/Compartment 049.
- Stand 62 – Add trail protection specs.
- Stand 8 – Add trail protection specs.

Compartment 072 (Stand Examiner – Dan Natzke)

- Stands 74 and 83 – Drop treatment.
- Stand 7 – Change to clearcut no retention due to stand size.
- Stand 11 – Look for element occurrence in MNFI database and add comments to protect.

Compartment 083 (Stand Examiner – Dale Parris)

- No changes.

Compartment 105 (Stand Examiner – Dale Parris)

- Stand 22 – Change MO to planted red pine.
- Stand 39 – Add spec to leave less than 10 square feet of BA of white pine as seed source.
- Reject proposed SCA's. Area is a floodplain, not necessarily recognized as a habitat area meeting SCA requirements.

Compartment 117 (Stand Examiner – Joyanne Mittig)

- Stand 29 – Review MNFI element occurrence and apply appropriate timing restrictions.
- Stand 2 – Contact RAS to remove road segment.

Compartment 145 (Stand Examiner – Collin Zaremba)

- Stand 3 – Consult with Fisheries to conduct a thinning within the buffer of the Rainy River. If Fisheries agrees, thin down to 80 BA. Remove hard factor.

Compartment 108 (Stand Examiner – Dale Parris)

- Stand 9 – Add NF treatment for lowland brush mgmt.
- Stands 41, 42, 44 – Add NF treatment for lowland brush mgmt.

Compartment 112 (Stand Examiner – Dan Parris)

- Stands 42, 43, 50, 40 – A thinning treatment. Remove hard factor.
