Comments from Stakeholders

Open House at the Crystal Falls Field Office, Crystal Falls, Michigan on September 20, 2017. Four visitors came to view maps, data and discuss prescriptions with staff. No written comments were received.

Compartment 10

Changes made at compartment review:

- Stand 6, remove treatment
- Stands 22, 23, 24, and 60, add opening maintenance treatments to the hunter walking trails in these stands, and delineate trails as separate stands.

Compartment 14

Changes made at compartment review:

- Stands 33, 42, 28, and 27, add opening maintenance treatments to these stands.
- Stands 2, 16, and 25 add scarification next step treatments. Wildlife will complete those treatments.

- Stands 10 and 19 add opening maintenance treatments, via mechanical or prescribed burn.

- Stands 60, 54, 93, 103, and 104, review site conditions and add as appropriate.
