Comments from stakeholders received prior to Compartment Review

Comment received from Tom Bogus regarding the Evert Block. “The area has had a huge number of trees harvested to the point where the remaining woods looks terrible. The areas where trees have been harvested are pretty much worthless now since you can’t even walk in them. The timber harvested often consisted of beautiful old trees and now the new growth consists of mostly aspen. The main reason we enjoy going to this forest is because of the beautiful trees. Please do not cut down any more of this forest, especially no more clear cutting.”

- Jim Park, DNR Forester, commented at Compartment Review that the area that is being referred to was final harvested after a very large blow-down event.

No changes at Compartment Review.


