### **Compartment specific changes made during the Compartment Review**

#### **Compartment 4 – Stand Examiner Tim Webb**

Incorporate travel corridor traversing stand 35 for retention. Recommend no chipping on stands 35 & 46. Stand 151, retain all mature beech. Drop prescription on stand 11.

#### **Compartment 15 – Stand Examiner Tim Webb**

No changes.

Compartment 22 – Stand Examiner Craig Allen

No changes, but further discussion needed between WLD & FRD.

Disagreement between FRD and WLD regarding treatment geometry on stands 94 & 99, further discussion will take place. Stands 85 & 90 will need further discussion between FRD & WLD local and district staff regarding the use of herbicide spray as a site prep treatment.

Compartment 32 – Stand Examiner Craig Allen

Extend WLD habitat cut treatment on stand 16 to include all or portion of stand 138 in compartment 61031.

Compartment 54 – Stand Examiner Pat Ruppen

Apply specs/comments to protect NCT where it interfaces with treatment on stand 114.

Stands 1, 50 & 53, change target basal area to 90-100.
