Set Concrete Monument. Measured 2657.82' between K09 and K08. Measured 2663.16' between K08 and K07.

Part B: Surveyor's Report on Perpetuation or Monumentation of Corner

I searched for but was unable to locate any evidence of the GLO corner, accessories or line trees. There is no concrete monument present per the notes of the FSU student project in 1974. I established this corner at record GLO deflection between K07 and K09, and at distances prorated to the GLO Resurvey. From this corner position, as established, I measured N02°51'48"E 2661.43' to K07 (GLO 2633.40') and S02°28'48"W 2656.10" to K09 (GLO 2628.12'). The condition of the witnesses are as follows: #1 and #2 gone.



Part C: Field Evidence of Perpetuation or Monumentation of Corner

I set a 4" by 20" long Harrison Cast Iron Monument stamped PS47956, to project 4" above grade as substantial marker for the corner and is accepted as a careful and faithful reestablishment of the position of the original Quarter
