





Found 3/2" x 24" Pipe in the centerline of graveled Larson Road as it extends west, & 8 foot west of the centerline of Larson Road as it extends south. The corner at this road intersection lies in an extreme fill area, appearing to be approximately 8 foot. The corner material found at this location is supported by Part A: Chronological history on above Page 1 and Page 2.

MDNR Witness (4) and MDNR Witness (5) were found intact. The witness measurements found are:
