 - (4) S57°W 31.7' – 14" Tamarack
- In 1981 Carl F. Roser found both of the 1909 Robinson witness & set a 1"x36" pipe with alum. Cap And established 3 witnesses.
 - (5) N12°W 31.5' – face of a 7" Cedar (no nail)
 - (6) S50°W 14.7' – face of a 7" Cedar (no nail)
 - (7) S20°E 16.3' – face of a 10" Cedar (no nail)
