*Discussion of comments from individuals:* Discussed the ability to maneuver through stand 10 if the cedar is reserved.

*Changes made at compartment review:*

- Stand 10: Reduce the size of treatment to the area near the hardwoods. May cut some cedar for operability.
- Stand 44: Change treatment to regen check, and make start date the same as the time clock year.

*Discussion of comments from individuals:* Discussed the desire to block a road going to an archeology site in one of the managed openings. Will need to pursue a director's order to close the road.
