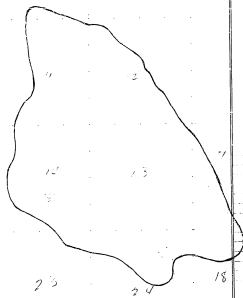

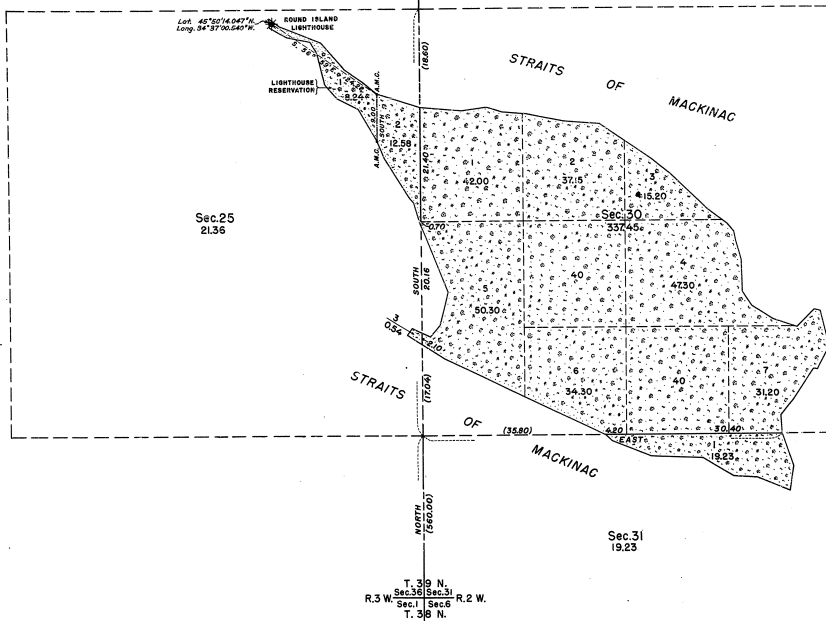

MEMORANDUM.

THIS PLAT DELINEATES THE SURVEY OF ROUND ISLAND IN THE STRAITS OF MACKINAC, WHICH WAS NOT INCLUDED IN PRIOR OFFICIAL SURVEYS IN THIS LOCALITY.

THE EAST BOUNDARY OF THE ROUND ISLAND LIGHTHOUSE RESERVATION IN SECTION 25, T. 40 N., R. 3 W., HAS BEEN ESTABLISHED ON THE ISLAND IN THE POSITION DESCRIBED IN EXECUTIVE ORDER NO. 2313 DATED NOVEMBER 25, 1930.

THE SURVEY WAS EXECUTED PURSUANT TO AUTHORITY CONTAINED IN GENERAL LAND OFFICE LETTER 1861775 "C" DATED AUGUST 19, 1941.
