

A. Description of original monument and accessories and/or subsequent restoration:

- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
- Found "T" Iron and 4 witnesses: Lewis tag in 30" W. Spruce N78W 47.67', Shiner in P.P. N40E 34.93', Shiner in P. Pole S85W 30.35', Conc. Mon. East 33.041, indicating this is the same corner position used by the surveyors mentioned above.

The position of this corner is accepted as a careful and faithful perpetuation of the position of the original corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner.

1997: Removed the existing "T" iron and set in its place a 1/2" iron rod with a 3" dia. brass cap, stamped to identify the corner, and set a Monument Box around the corner.
