B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

M7: Found 1/2" Rebar with cap damaged and all of the BI's of the 1992 report in good condition. The bottom portion, 2" G.I.P., of the Alger County Standard monument, 1916, is upright and in usable condition. Measurements to existing corners South and North support the corner position. Remains of old Alger County standard monument at corner position are solid and have been accepted as a careful and faithful perpetuation of the position of the original corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

M7: Set in place of exist. 1/2" rebar a 5/8'x 18" rebar with Berntsen 3 1/4" aluminum cap no. RBD5325, stamped to identify corner position, grouted in place with concrete. Renewed and upgraded the following exist. reference trees with paint and BT signs.** Maple 24°, N.45 N., 52.70 feet, PK w/brass washer.** Maple 22°, S.84 W., 43.83 feet, PK w/brass washer.** Maple 7°, N.59 E., 67.0 feet, PK w/ aluminum I.D. washer.** Maple 9', S.48 E., 45.9 feet, PK w/ aluminum I.D. washer. All bearings are magnetic.
