Jamros, RLS, 1988, Found 5/8' iron bar in hand hole south of centerline asphalt road. References: Maple 7°, N.22 W., 64.1', Balsam Fir , S.13 W., 33.8', P.pole, S.53 E., 40.4'. Filing No. 3-338, Alger County Records.

## B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

I1: Found 5/8 inch iron bar in monument box 0.8 feet south of centerline of H-58 (old M-94) and 16.3 feet west of centerline of road to north. Verified remaining references of 1988 report. Measurements to adjacent corners east and west support corner position. A search was made at GLO bearing tree positions, evidence has been lost to road construction. Corner position is accepted as the best available evidence of the position of the original corner.
