A. Description of original monument and accessories and/or subsequent restoration:

C3: PLS * George E. Adair, DS, 1851. * Set post corner of Sections 5, 6, 7 and 8. * Beech 7', N.80 W., 30 links. * Beech 15', S.71 E., 31 links. ***** No other subsequent restoration of record.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

C3: Located corner search area by calculated position and standard field survey. Found only a paint line running South from this position. Established corner position by extending line South from section corner and 1/4 section corner North of position at a distance proportional to the North 1/2 nile of section line. No evidence of post or original BT's. GLO distance to lake North of corner was 231 feet, measured 246 feet. GLO distance to lake East of corner was 66 feet, measured 85 feet. GLO distance to top of hill South of corner was 198 feet, measured was 210 feet, more or less. GLO distance to top of hill West of corner was 330 feet, measured was 340 feet, more or less. Corner position as established is accepted as a careful and faithful reestablishement of the position of the original corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

C3: Set 2 1/2"x30" Berntsen aluminum monument No. A1NB30 with 3 1/4" aluminum cap stamped to identify corner position. * Established the following reference trees with BT signs, blazed, scribed and painted. * Set PK nails with aluminum I.D. washers for measure in the following: Maple 8", S.82 W., 15.26 feet, "S7 BT". * Maple 6", N.47 W., 32.81 feet, "S6 BT". * Maple 10", N.73 E., 33.64 feet, "S5 BT". * Maple 8", S.49 E., 32.83 feet, "S8 BT". * Survey marker sign on 6 foot steel post, N.27 W., 1.3 feet. * All bearings are magnetic.
