East-West track road has been widened and conument has been destroyed. \* Evidence of paint or blaze lines not evident, area quite open with small amounts of timber. \* Established corner position on true line at midpoint between section corners North and South \* Corner position is accepted as a careful and faithful reestablishment of the position of the criginal corner.
