(K-9) ORIGINAL CORNER POST ESTABLISHED BY U.S. GOVERNMENT DEPUTY SURVEYOR C. BRITAIN, 1831. ACCESSORIES: W. DAK 28 S49E 67, PINE 13 S8BW 52. FOUND NO SUBSEQUENT RECORD.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(1-9) ORIGINAL POST AND ACCESSORIES NOT RECOVERED. MacDOUGALL'S STAKE AND ACCESSORIES NOT RECOVERED. REESTABLISHED CORNER MIDNAY IPROPORTIONATE TO ORIGINAL MEASURE) AND ON A STRAIGHT LINE BETWEEN 1-10 AND 1-8 AS RECORDED THIS DATE. DID NOT PROPORTION EAST-WEST DUE TO A SUSPECTED ERROR IN ORIGINAL MEASURE ALONG THE SOUTH LINE OF SECTION 23. DISTANCE WEST (2653.27') FROM THIS POSITION TO AN OLD FENCE LINE AT H-9 IS VERY MEARLY IN THE SAME PROPORTION TO MACDOUGALL'S MEASURE AS DISTANCE BETWEEN 1-8 AND 1-10 (5264.9' MEASURED). AT THE POSITION ESTABLISHED, I PLACED A 1/2°x36" REBAR ENCASED IN A 4" DIAMETER CONCRETE CYLINDER CAPPED WITH A CAST ALUMINUM MICHIGAN DEPARTMENT OF NATURAL RESOURCES TABLET.

(K-9) ORIGINAL POST AND ACCESSORIES NOT RECOVERED. FOUND CORNER MONUMENTED WITH A 1/2" PIPE AND A 5' HIGH WOLMANIZED WOODEN POST ADJACENT. PIPE CHECKS ACCEPTABLY WITH GOVERNMENT CORNERS NORTH AND SOUTH. MEASUREMENT WEST TO J-9 IS 15.5' SHORTER THAN GLO RECORD AND WEST TO I-9 IS 47.5' SHORTER. THIS DISCREPANCY IS NOTED AS A PROBABLE ERROR IN THE ORIGINAL MEASURE.
