Description of original monument and accessories and/or subsequent restoration:

E-13 Set post - H. Parke, 1831. Pine 8" N 32° W 17 Lks.

Pine 8" N 54-1/2° E 31 Lks.

Arenac County Surveyor notes - 1905, 1907, and 1923 - Post distance and angle ties N, E, and W. L.C.R.C. - L. 2, P. 279 - 1977 - McGinnis - Bay County Records.

Recorded Surveys - L. 762, P. 155 - 1975; L. 752, P. 336 - 1974; L. 897, P. 279 - 1980 - Bay County Records.

Recorded Survey - L. 1, P. 421 - 1981 - Arenac County Records.

<u>F-13</u> Set post - H. Parke, 1831. W. Oak 30" N 50° W 2-1/2 Lks. Sugar 10" N 76° E 33 Lks.

County Surveyor notes - 1907 - Post with distance ties E and W. County Surveyor notes - 1923 - Post with broken wagon skein. Distance ties E and W.

Recorded Survey - L. 1183, P. 956 - Bay County Records - 1/2" rod 5.94' W of F-1, T17N, R4E (1/2" rod).

Description of corner evidence found and/or method applied in restoring or reestablishing corner:

E-13 Standard corner common to Sec. 32 & 33, T18N, R4E, and Sec. 4 and 5, T17N, R4E. Found 3/8" rebar per L.C.R.C. - L. 2, P. 275 and recorded surveys. Monument accepted as the best available evidence of the position of the original corner. Accepted by Arenac County Peer Review Group on 11-17-93.

F-13 Standard 1/4 corner for Sec. 33, T18N, R4E. Found 1/2" rebar at single proportional measurement between E-13 and G-13, T18N, R4E by Ledy Engineering. Fits 1907 County Surveyor distance to E-13 and G-13. Excavated below 1/2" rebar. Found no evidence of post or wagon skein. 1/2" rebar accepted as the best available evidence of the position of the original corner. Accepted by Arenac Peer Review Group on 11-17-93.



C. Description of monument for corner and a blished to perpetuate locating the position of the corner:

E-13 Replaced 3/8" rebar with 3-1/4" Bay-Arenac County brass cap on 5/8" x 24" rebar in mon. box.

N 18° W 48.83' to PK and tag in SE side U.P. N 73° E 42.72' to capped 3/8" rebar.

S 27° E 52.62' to PK and tag in W side U.P.

S 57° W 30.67' to PK and tag in W end concrete culvert.

S 72° W 39.30' to PK and tag in N side 24" Cottonwood.

F-13 Replaced 1/2" x 1' rebar with 3" Arenac County brass cap on 5/8" x 24" rebar with 4" plastic drain tile sleeve with concrete. Punch mark in SE quadrant.

S 70° E 188.67' to nail and tag in N side U.P.

N 80° E 116.59' to nail and tag in NW side 8" Elm.

N 6° E 120.81' to nail and tag in W side 12" Ash.

N 12° E 74.10' to nail and tag in W side 18" Elm.

E 5.90' (5.94' - R) to 2-3/4" Bay County brass cap in mon. box (F-1 - T17N - R4E).
