A. Description of original monument and accessories and/or subsequent restoration:

C 10 Set 1/4 Section post - J Burt - 1843. Aspen 10" N 50° E 1-1/2 L. Do. 7" S 17° W 7 L.

Arenac County Surveyor Notes - 3/4" bolt and distance ties to C 9 and C 11- G. H. Hollister.

Unrecorded Survey - Edmands Engineering (now Wade-Trim, Inc.) #2399 - Found 5/8" bar at surface - 1963.

Unrecorded Survey - Edmands Engineering (now Wade-Trim, Inc.) #5347 - Section sub. of Section 30, T18N, R5E using 5/8" bar as E. 1/4 corner - 1968.

LCRC - L.1, P. 159 - found 3/4" pipe, solid rod 3.3 NW. - Mueller -1981.

Recorded Surveys - L.1, P. 285 - found 3/4" pipe - 1976; L. 1, P. 438 - 444 - found 3/4" pipe - NW. 3.3' to solid rod; L. 1, P. 425 large pipe - 1981; L. 1, P. 624, 3/4" bar - 1989; L. 2, P. 64 - 3/4" bar - 1993.

Description of corner evidence found and/or method applied in restoring or reestablishing corner:

C 10 Found bent 3/4" solid iron rod per unrecorded Edmands surveys (5/8" rod), L. 1, P. 624 and L. 2, P. 64, 3' W. of physical centerline of Lentz Road. This being the solid rod noted in LCRC L. 1, P. 159 and L. 1, P. 438 - 444. Excavate position - find remains of wood stake 1" - 2" diameter x 1' long along side of rod from 0.6' to 1.6' down. Position in agreement with County Surveyor Notes proportional as follows: 2638.89' -M 2640' (ACSN) to C 9, 2636.14 -M, 2636.7 (ACSN) to C 11. Found wood stake is consistent with wood stake found in center of 2" pipe per ACS notes at C 9. Bottom of wood stake and bent 3/4" rod used as corner position. Monument accepted as the best available evidence of the position of the original corner.

Reference Pt "A" - 3/4" pipe per LCRC L. 1, P. 159 and Recorded surveys L. 1, P. 285; L. 1, P. 438-444; L. 1, P. 425. 3/4" pipe was not found. Excavated position per witness-find no corner evidence. Set 3/8" rebar by witness at physical centerline Lentz Road - N & S. Distance to C 9 - 2639.8' -M (2640 - ACSN) and C 11 - 2635.25 -M (2636.7 - ACSN). Position not in agreement as well proportionally as solid rod accepted as C 10 - Monument was established using improper procedures and is not utilized as C 10-T18N-R5E in this survey.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Replace 3/4" solid rod and wood stake with 3" Arenac County brass cap on 5/8" x 24" rebar with 4" plastic sleeve with concrete - down 0.5'.

N 40° W 82.57' (81.7' -R to face) to nail and tag in SW. side U.P.

N 85° W 22.45' (22.6' -R) to pk and tag in S. end 36" CMP.

N 38 ° E 30.82' to capped 3/8" rebar.

S 22° E 33.77' to capped 3/8" rebar.

S 72°52' E 2.89' (3.3' -R) to Reference Pt "A" - 3/8" rebar.
