

Stephan J. A. Description of original monument and accessories and/or subsequent restoration:

(13-Sec. 27) Southeast 1/16 corner, Section 27. Not established in the original survey.

(14-Sec. 27) South 1/16 corner between Sections 26 and 27. Not established in the original survey.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(13-Sec. 27) Established the corner at the intersection of straight lines connecting opposite 1/16 corners.

(14-Sec. 27) Established the corner midway and on the Section line between Section corner 1315.08' south and Quarter corner 1315.08' north.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(13) Set 1"IDx32" I.pipe with 4" alum. MDNR cap. Set measuring nail with MDNR tag in the side of: 5" W.Birch North 3.1' mrkd "1/16S BT" 9" Cedar N39E 6.8' do 6" W.Birch S56E 19.8' do do 13" Cedar S05E 10.4' Set sq'd cedar post adjacent. Bearings are magnetic.

(14) Set 1"IDx32" I.pipe with 4" alum. MDNR cap. Set measuring nail with MDNR tag in the side of:
