- (H7) Quarter corner common to Sections 15 and 22. 1848 Established by Wells Burt Deputy Surveyor midway and on the Section line between monumented Section corner G7 39.88 chains west and unmonumented Section corner I7 39.88 chains east. Set Y.Birch post. Cedar 18 S86E 28 links, Cedar 8 N85W 14 links.
- (I4) Quarter corner common to Sections 10-11. 1848 Established by Wells Burt Deputy Surveyor midway and on the Section line between Section corners 40.00 chains north and south. Set Sugar post. Sugar 9 S27E 27 links, Sugar 8 N69W 37 links.
- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
- (H7) The original post and accessories were not recovered. The original Meander Corner on the west shore of Coon Lake was not recovered. Found no evidence of the position of the original corner on the ground. Reestablished the corner midway and on the Section line between Section corners 2633.28' east and west. The position for Section corner I7 falls in Coon Lake and is not monumented. For the purpose of the establishment of H7, the position of I7 was computed by double proportionate measurement to the original record between corners G7, J7, I6, and I8.
