(J5) Quarter corner common to Sections 11 and 14. 1848 - Established by Wells Burt Deputy Surveyor midway and on the Section line between Section corners 40.02 chains east and west. Set maple post. Spruce 12 S34E 36 links, Spruce 14 N25W 28 links. 1957 - Dean C. DeLaMater RLS searched for this corner on behalf of the Michigan Dept. of Conservation and found no evidence.

(5-Sec. 14) North 1/16 corner, Section 14. Not established in the original survey.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(J5) The original post and accessories were not recovered. Found no acceptable evidence of the position of the original corner on the ground. Reestablished the corner midway and on the Section line between Section corner I5 2639.68' west and Section corner K5 2639.68' east, proportionate to the original record. The position used for K5 is in Nelligan Lake and is not monumented. Its position was determined by extending the East line of Section 11 southerly by the record distance (586.84') from the Witness Corner to the Meander Corner on the north shore of Nelligan Lake, monumented by R.Schmeling RLS and recorded in Liber 4, Page 116, Land Corner Records, Baraga County.
