A. Description of original monument and accessories and/or subsequent restoration:

(2-Sec. 30) East 1/16 corner between Sections 19 and 30. 1978 - Established by K.L.Sackett RLS on line between corners east and west. Set 1"IDx36" iron pipe with 4" alum. cap. 4" Sugar N11E 15.6', 3" Sugar S30W 3.0', 10" Y.Birch S63E 5.2'.

(12-Sec. 30) South 1/16 corner, Section 30. Not established in the original survey.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(2-Sec. 30) Found the 1978 monument in good condition and at record bearing and distance from the 1978 witnesses. The Sugar NE is standing dead, the Sugar SW and Y.Birch SE are in good condition. accept the monument as a careful and faithful establishment of the position of the corner. Made the monument firm in a mound of rock.

(12-Sec. 30) Established the corner midway and on a straight line between Quarter corner 1290.15' South and Center of Section 1290.15' North. The position for the corner falls in an inaccessible area and was not monumented. Established a Witness Corner, on the N-S 1/4 line, 187.00' south of the position for the corner. Monument was made firm in a mound of rock.
