

- A. Description of original monument and accessories and/or subsequent restoration:
- (B10) Center of Section 30. Not established in the original survey.
- (5-Sec. 30) North 1/16 corner, Section 30. Not established in the original survey.
- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
- (B10) Established the corner at the intersection of straight lines connecting opposite Quarter corners. The position for the corner falls on a nearly vertical rock outcrop about 3 ft. above a ledge. The corner monument pipe was bent to conform to the rock face and was made firm with a mound of rock 4.5' long x 3.4' wide x 2.3' high. The center of the monument cap marks the corner position.
- (5-Sec. 30) Established the corner midway and on a straight line between Center of Section 1312.93' south and Quarter corner 1312.93' north.
- C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:
