Private Claims , 19 <u>96</u> do hereby state Michael Mileski , in a field survey on November that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and /or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as expressed below: NOTE: Not more than 2 corners, all in the same town and range, may be recorded on this certificate. 10 A. Description of original monument and accessories and/or subsequent restoration: F-13; South One-quarter Corner Section 33, T51N, R31W, on Fifth Correction Line; Originally established during U.S. Survey conducted by Austin Burt, D.S. in 1845 APPROVED LAND CORNER and monumented by a 16" diameter birch. No accessories were noted. P.A. 345 OF 1990 Baraga County No subsequent record of this corner was found. B. Description of corner evidence found and/or method applied in restoring or reestablishing corner: F-13; South One-quarter Corner Section 33, T51N, R31W, on Fifth Correction Line; This corner was considered lost and reestablished midway and on line between the standard corners immediately to the east and west. The SW corner of section 33 is an original corner and the SE corner of section 33 is probably an original corner. Corner location falls 4 feet east of the physical centerline of an unimproved, 18 foot wide, gravel road which at this point bears north and south. C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

- F-13; South One-quarter Corner Section 33, T51N, R31W, on Fifth Correction Line;

Set a 1"(I.D.) x 28" galvanized iron pipe with a 2" aluminum cap stamped as to location 12" below the road surface.
