B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

COULD NOT FIND CORNER

FOUND 4" CAST IRON PIPE AT NORTH 1/4 POST SECTION 20 NO WITNESS REMAINING. FOUND 3" X 1/4" CAST IRON STAKE AT NORTHWEST CORNER OF EAST 1/2 OF NORTHWEST 1/4 SECTION 20 AS PER BATEMAN SURVEY SONE WITNESS REMAINING)

DOUBLED OVER DISTANCE FROM NORTH 1/4 POST SECTION 20 TO NORTHWEST CORNER EAST 1/2 NORTHWEST 1/4 SECTION 20 TO EAST AND SET NORTHEAST CORNER SECTION 20 ON LINE. ACCEPTED THIS LOCATION AS PERPETUATION OF CORNER AS USED BY BATEMAN IN 1899.
