B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

 $\underline{E3}$ Found capped 3/8" rebar #39088 at surface in 3/4" l.D. x 2.7' long iron pipe in mon. box - down 0.4' - per Spicer Eng. notes, BCRC witness book, LCRC's and recorded surveys. Monument accepted as the best available evidence of the position of the original corner.

Reference Pt "A" - 3/4" iron pipe called for in 1957 Spicer Notes and 1958 C.P.Co. survey being 2.5' S. of E 3 - not found - C.P.Co. survey calls for 2627.95' N. to E 2 vs 2625.90' (L. 822, P. 519) and 2625.6' (L. 1058, P.3) North to E 2 per recorded surveys. This position has not been used as E 3 by Spicer 1957 survey or recorded surveys. Spicer notes and recorded surveys have used the recorded 3/4" pipe in mon. box accepted as E 3. Monument established using improper procedures and is not utilized as E 3-T14N-R5E in this survey.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

E 3 Replace capped 3/8" rebar, 3/4" pipe and mon. box with 2-3/4" Bay County brass cap in 5/8" x 24" rebar in mon. box.

N 30° E 83.35' to nail and tag in W. side 4" Spruce.

N 50° E 97.01' to pk and tag in NW. side U.P.

N 55° W 132.95' to nail and tag in N. side U.P.

S 35° E 127.70' to SW corner block foundation of House #3509.

S 42° W 73.43' to pk nail in E. side U.P.

N 43° W 180.54' to NE. corner stone block foundation of house. South 2.5' (C.P.Co.) 2.47' (Spicer Notes) to Reference Pt "A".
