

B 11 Corner established by single proportional measurement between A 11 and C 11 per CPC survey and recorded survey being 2638.71' (36.6 Ch - GLO) E. of A 11 and 2665.25' (40 Ch -GLO) West of C 11. In agreement with fence line to North and on E. side of hedge row S. Monument corner position accepted as a careful and faithful re-establishment of the position of the original corner.

Reference Pt. "A" - Found 3/4" iron pipe per LCRC L. 3, P. 14 -Monument was established by Doubling the E. 1/8 line fence distance W. of C 11. Monument 4'± E. of existing fence line to N. Monument was established using improper procedures and is not utilized as B 11-T15N-R3E in this survey.
