A. Description of original monument and accessories and/or subsequent restoration:

M-12 Set post - J. Wampler, D.S. - 1822. Fnd old corner - George Turner - October 1908. No call - Edmands Engineering Notes - 1959 - Janicke Subdivision, L. 8, P. 10, angle and distance to N and S. Set Iron - Recorded Survey - L. 654, P. 224, Edmands Engineering - June 1, 1971. Fnd iron - <u>L.C.R.C.</u> - L. 1, P. 57 - June 10, 1971. Fnd - L.C.R.C. - L. 1, P. 260.

Description of corner evidence found and/or method applied in restoring or reestablishing corner:

M-12 Reestablished location by angle and distance from M-11 and M-13 based on 1959 Edmands Engineering Notes and recorded plat of Janicke Subdivision, L. 8, P. 10, very sligh reaction with locator, dig hole 2'+ in diameter, at 0.4' through bit and into grav, at 0.9' through grav into sand fill, at 1.2' through sand into old oiled road surface, at 1.5' through old road into sand fnd top of 2 rocks side by side 6" in diamter x 12" long standing on end.

Witness and remove rocks and dig around and under rocks at 3.2' hit clay layer backfill and replace rocks. S side of and in between rocks is location as established from Janicke Subdivision retracement. Accepted location S of centerline and in between rocks as best available evidence of the position of the original corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner;

M-12 Set Bay County Remonumentation mon (5/8" x 24" rebar with brass cap marked by 3/16" drill hole) in between 2 rocks and mon box at 2'± W of centerline road.

E 39.50' to Bay Co nail and tag in S face of P.P. S 70° E 125.94' to NE cor of cem blk fndt of Hse #250. N 10° W 148.28' to Bay Co nail and tag in W face of P.P. S 40° W 32.94' to Bay Co nail and tag in SE face of 6" Elm. S 40° E 51.66' to Bay Co nail and tag in SW face of 14" Pine. N 70° W 132.92' to SW cor cem blk fndt of Hse.
