A. Description of original monument and accessories and/or subsequent restoration:

1838: GLO set post and witnesses - 6" Beech N31°W 28 links and 6" Beech N23 ½ °E 30 links. 1911: Frank Haswell, Survey Records II, Page 112, drove a 1" x 4' long iron pipe equidistant and in a right line between opposite section corners. Haswell distances to East and West was 2629.44'. 1964: BCRC found iron pipe and witnessed it. 1979: William P. Richards, Liber 1 of Surveys, Page 620, found ½" iron pipe. 1990: Richard Wilcox, Liber 2 of Surveys, Page 116 and LCRC in Liber 1, Page 264, shows found 5/8" iron pipe in centerline of road and witnessed it.

B. Description of comer evidence found and/or method applies in restoring or re-establishing comer:

1999: Found ½" x 18" iron pipe at grade with a ½" x 14" iron pipe next to it and below existing road grade. Distances fit very well with Haswell distances. 2630.22' to the West and 2631.11' to the East. Distance to West also checks well with distance measured by Wilcox. The Benzie County Peer Group accepted the ½" iron pipe as a perpetuation of Haswell's comer per his 1911 survey.
