- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
- E-2 ¼ Corner common to Sec.'s 4&5, T26N,R13W FND. ¾"x 1.9' long Iron Pipe, (2577.2' North of E-3, vs. 2640' GLO), w/ fence post guard per NGMB notes, within 2' ± of SP position between E-1 & E-3. Further investigation in this area finds that the overall distance between E-3 & E-1 is 5375.6', measured, vs. 5510' GLO, a shortage of 134'. From E-3 North to the S. bank of the Platte River is 3650' GLO; vs. 3742'± 10', measured an over-run of 92'±. A retracement of Tuller's survey in Sec. 5 by monumentation and occupation calculates 98.4' North of the ¾" Pipe by extending a line from C-2 thru D-2. At the ¾" Pipe, 2 strands of barbed wire on ground & in trees; meanders N to the river. 17'± S of the Pipe E-W fence remains & a field line bears N85°E. An old N-S field line w/ traces of fence is 80'± 20' to the West of the Pipe. These field lines are apparent on 1938 aerial photos. An extensive search was made for evidence of Tuller's position to 110'± North of the ¾" Pipe. The Sugar Maple trees in this area are 16" ±, or smaller and not considered to be of an age that represent Tuller's NBT's. No physical evidence of Tuller's position found. Due to inconsistencies between Tuller's distances and our measurements around the SW1/4 of Sec. 5, extending the E-W ¼ line from C-2 thru D-2, to the east, is an inconclusive position for the corner. Accept FND. ¾" Iron Pipe as the best available evidence of the position of the original corner.
