- Description of original monument and accessories and/or subsequent restoration:
- 1830 government surveyors set stake 9 links east of SE cor 34-5-19. Accessories: 15" Beech S 20° W 22 links, 5" Beech N 71° E 7 links. Circa 1950 J.H. Dewey Iron Pipe, Accessories: Iron South 33', corner headwall NW 30', 2" Pear SE 4.0' S cor. East headwall east 15.1', NE cor west headwall NW 20.2', SE cor west headwall SW 20.7', pear SE 37.1', elect pole SE 62.8', W & A notes dist. from N\(\frac{1}{4}\) 3-6-19 to NE cor 3-6-19 = 2645.5'. 1960 N & A notes SW cor 35-5-19 to s\(\frac{1}{4}\) 35-5-19 = 2650.50'.
- Corner not set by original government surveyors. November, 1886 Luther Hemingway does not show jog at this corner. Circa 1950 J.H. Dewey stone does not show a jog. August 29, 1966 W & A RR spike dist. to SW Cor. on 35-5-19 is 2650.0°. Nov. 20, 1978 Barger notes for survey in section 2 found RR spike, Accessories: CL PP S 55° E 66.7° CL PP S 70° W 98.0°, CL 18" Maple N 70° W 98.6°. Feb 7, 1990 John G. Kamer RR spike in CL road, Accessories: PK in PP S 70° E 66.62°, PK in PP S 70° W 98.17°, SW cor. frame house S 50° E 122.64°.
- Description of corner evidence found and/or method applied in restoring or reestablishing corner:
- I-1 No evidence of corner found. Set corner found. Set corner 5.94' East of SW cor. sec. 35-5-19 in new Mon. Box.
- Found RR spike in road. Distances to adjacent corners were reasonable and consistent. Accepted spike as best evidence of corner. Corner common to St Sec. 35-5-19.



- C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:
 - Set standard 10" pipe w/brass plate in Mon. Box and is accepted as a careful and faithful reestablishment of the position of the original corner. Also a twisted 1" IP in Mon. Box is no good (could not remove this pipe)
