A. Description of original monument and accessories and/or subsequent restoration:

G.L.O. - J. Mullett, D.S., 1825-26: "80.00 Set post cor sec's 1 & 12"

E.R. Reed, Co. Surveyor, 1956 Fieldnotes: "Fd. 10" stone, tin, concrete & china, 12" deep, Set 12" iron rod on top, took witnesses".

E.R. Reed, Co. Surveyor, 1972: Recorded L.C.R.C. #051. Found corner as located in 1956. from witnesses Set RLS-capped 3/4"x18" iron rod; took additional witnesses;

- D. Scott, RLS #12029, DNR, 1972: "Section corner ties and distance along North Section line and plats furnished by Ed Reed, County Surveyor".
- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

On Sept. 10, 1996, I attempted to recover corner from witnesses on L.C.R.C. #051 & prior survey witnesses. The RLS-capped iron described on L.C.R.C. #051 is now gone, but a 19 rebar iron with identification cap "CUTCHER #24592" was found near corner location.

F. Cutcher, by phone, on Sept. 10, 1996, denied any knowledge of this corner or his capped iron at this location, or if it represented the section corner.

Therefore, on Sept. 19, 1996, I reset the corner by traverse from existing plat monuments of OAK GROVE PARK PLAT, OAK GROVE PARK PLAT NO. 2, nearby survey markers and witnesses from 1956 fieldnotes and L.C.R.C. #051 witnesses.

SET a 1/2"x 24" steel rebar rod in concrete with Branch County Remonumentation Cap, in CI-monument box.

And is accepted as a careful and faithful reestablishment of the position of the original corner.
