DUG TO DEPTH OF OVER 3 FEET & STILL IN ROAD GRAVEL. UNABLE TO FIND STONE. IT APPEARS THAT STONE MAY HAVE BEEN REMOVED IN ROAD BUILDING. REESTABLISHED CORNER BY PROTRACTION OF SECTION LINES FROM SOUTH, EAST, WEST, AND NORTH USING COLDWATER TWP. T6S, R6W (SECTION LINE 31/32), AND PRORATION OF GLO OFFSET OF 37 LINKS PLUS 128 LINKS.

SET A 1/2" X 18" REBAR IRON ROD WITH I.D. CAP #7437, IN MONUMENT BOX, AT THIS POINT, AS A CAREFUL AND FAITHFUL REESTABLISHMENT OF THE POSITION OF THE ORIGINAL CORNER.
