Found standard monument over ½" bolt over stone in monument box. The accessories of the July 26, 1974 survey by Don Peirce verify location of corner. Distances to adjacent corners were reasonable and consistent. Accepted the standard monument as best evidence of corner.

Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Set standard 3/4" x 2' pipe with aluminum cap over the stone in place of the standard manufert and ½" bolt in monument box, and is accepted as a careful and faithful perpetuation of the original corner. 🔊 🖏
