- A. Description of original monument and accessories and/or subsequent restoration:
- (J11) Quarter corner common to Sections 26 and 35. 1979 Reestablished by Billy D. Buckler RLS midway and on line between two section corners. Set 1" pipe with 4" aluminum cap. 8" W.Birch N18W 9.4', 6" W.Birch S26W 9.7', 6" W.Birch S62E 26.7'.
- (2-Sec. 26) East 1/16 corner between Sections 23 and 26. 1979 Established by Billy D. Buckler midway between Quarter corner to west and Section corner to east. Set 1"ID I.pipe with 4" aluminum cap. 7" Aspen N66W 3.4', 14" Spruce S71E 33.5', 8" Spruce S43E 20.2'.
- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner: (J11) Found the 1979 monument in good condition and at record bearing and distance from the 1979 witnesses. The W.Birch NW and the W.Birch SW are in good condition. The W.Birch SE is dead. Verified the position of the monument as being 0.4' south and 4.1' west of the position midway and on a straight line between Section corners east and west and I accept the monument as the reestablishment of the position of the original corner.
- (2-Sec. 26) Recovered the 1979 monument disturbed but in good condition N14E 57' from the position of record, it apparently having been moved by persons unknown. Removed the monument and reinstalled it at the record position, in accord with the record bearing trees, said position being substantially at the midway position between Quarter and Section corners. Note that the record distances to the Spruce BTs in the SE were transposed on the 1979 record.
