- A. Description of original monument and accessories and/or subsequent restoration:
 - (C-1) Closing Corner of Sections 5 & 6 (T43N-R2E)

Neal Sperhake, L.S. 7876 (Kimberly Clark Corp.). Witness Corner recorded in Liber 3, Page 119 of the Chippewa County Corner Records. Re-established corner position 26.40' West of the Standard Corner (iron pipe) to the East. Set a 1" pipe with stamped aluminum cap as a Witness Witnessed the witness corner. Corner 33' South.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner: This corner is being perpetuated as part of the Chippewa Remonumentation Program.

Found a PK nail 24.88' West of the Standard Corner (a 12" O.D. pipe) and 32.75' North of the record Witness Monument. Accepted corner position as found and offset prior to road reconstruction. Replaced corner after construction completed.

Note: Corner falls 0.59' South of the Township Line.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner: Corner is a 3/4" x 24" iron with plastic "Chippewa County Remonumentation" Corner falls 2.5' North of centerline Gogomain Road (East-West, paved). 25' West of centerline of Cole Road to the North (North-South, gravel).
