

A. Description of original monument and accessories and/or subsequent restoration:

1/2 Corner Common to Sections 33 & 4 (T44N-R1E)

1840: Corner established by Austin Burt for William A. Burt. Set & Section Post.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

This corner is being re-established as part of the Chippewa County Remonumentation Program.

Found no evidence of original corner. Found a North-South fence line on the North side of the road. Re-established corner position on line between the Southeast and Southwest corners of Section 33 on the extension of a fence line to the North. Distance East to the Southeast corner of Section 33 is 2647.45. Distance West to the Southwest corner of Section 33 is 2649.05'.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner. (F-13) Corner is a 3/4" x 24" iron with plastic "Chippewa County Remonumentation" cap. Falls 7' North of the centerline of Gogomain Road (East-West, paved). Falls on extension of fence line to the North. Falls approximately 16' West of extension of the centerline of Gogomain Road (East-West, paved). of fence line to the South (fence is on East side of Drive).
