

I, Keith R. A. Description of original monument and accessories and/or subsequent restoration:

K-3 Corner Common to Sections 1, 2, 11 & 12, T44N, R1W.

1845 – Original corner established by James H. Mullett.
Witnesses: Hemlock 16, N45°E 23 links – White Pine 30, S62°W 20 links.

Found no evidence of subsequent restoration of this corner.



B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

This corner is being reestablished as part of the Chippewa County Remonumentation Program.

Found no evidence of the original corner. Reestablished corner by double proportionate measurement, using the closing section corner on the township line at K-1 to the north, the section corner at K-5 to the south, the section corner on the meridian at M-3 to the east, and the section corner at I-3 to the west. A squared wood post, which I believe was set by a local landowner or timber cruiser, bears S19°E 142.5 feet from the reestablished corner location.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Placed a ¾" x 24" rebar with a stamped aluminum Chippewa County Remonumentation cap the corner location. Witnesses:
