A. Description of original monument and accessories and/or subsequent restoration:

Corner Common to Sections 3 & 4, on the North Boundary of T44N, R2W. (Closing Corner on Township Line)

Original ties to post: Spruce 12, S60°W 50 links Spruce 6, S43°E 20 links. 1959 - Highway Department, as recorded in liber 2, page 235, liber 2, page 238, and liber 3, page 229, Chippewa County corner records. Corner is called out as a 1" iron bolt, a 1" iron pin, and a 1" iron bolt, respectively. Various fence posts and utility poles as shown as witnesses. It does not appear that double corners were recognized. 1988 - Corner is shown on a certificate of survey by Larry Rogers, P.S. 29251.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

G-1 (T44N, R2W)
This corner is being perpetuated as part of the Chippewa County Remonumentation Program.

Found a 1" iron bolt as called for in previous Highway Department records and as shown on above mentioned certificate of survey. Position works well with other corners and occupation on township line east and west, and is on the approximate centerline of the extension of a road to the south. Corner falls inside the right-of-way fence on the east side of Highway I-75 STAND OF Accepted corner as found and established new witness objects.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner.

Corner is 1" iron bolt inside the right-of-way fence on the east side Highway I-75. Witnesses:
