

5. Private Claims

I, Keith R. A. Description of original monument and accessories and/or subsequent restoration:

G-6 1/4 Corner Common to Sections 15 & 16, T44N, R2W

1845 - Original corner (6" Spruce) established by James Mullett.

1897 - Chippewa County Surveyor Frederick H. Brown, RLS 944, notes for Section 15 show the west line with distances of 2646 feet for the north ½ mile and 2642 feet for the south ½ mile.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

This corner is being perpetuated as part of the Chippewa County Remonumentation Program.

Found a ½" rebar 3 feet west of the centerline of Hantz Road, on the extension of a field line to the east. Found rebar is midway on line between section corner G-5 to the north and G-7 to the south. Accepted corner as found.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Found a ½" rebar at the corner location, which falls 3 feet west of the centerline of Hantz Road, on the extension of a field line to the east. Witnesses:
