I, Keith R. A. Description of original monument and accessories and/or subsequent restoration:

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

This corner is being perpetuated as part of the Chippewa County Remonumentation Program.

Found a 4" diameter concrete monument approximately 2 feet west of the centerline of a north-south dirt road, on the extension of a fence line to the east. Also found the power pole witness as called for in the 1983 LCRC and four other existing bearing trees, which appear to have been established recently.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Found a 4" diameter concrete monument at the corner location, which falls approximately 2 feet west of the centerline of a north-south dirt road, on the extension of a fence line to the east. Witnesses:

Nail and plastic tag #27450 in side of blazed 9" Spruce, N43°E 40.60' Nail and plastic tag #27450 in side of blazed 6" Spruce, S43°E 47.24' Nail and plastic tag #27450 in side of blazed 4" Balsam Fir, S73°W 46.10' Nail and plastic tag #27450 in side of blazed 5" Spruce, N83°W 22.03' Nail and plastic tag #27450 in Power Pole (RU3/36/11), S13°E 130.38'
