(J-1) This corner is being perpetuated as part of the Chippewa County Remonumentation program.

Found a 1/2" iron w/cap No.29251 on the extension of a North-South 1/4 line fence in Section 2. Corner falls 16.27' East of the South 1/4 corner of Section 35, (GIO is 17.49'). Accepted corner position as found.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(J-1) Corner is a 1/2" iron with cap No. 29251 and falls 11.4' North of the centerline of 12 Mile Road.
