B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

B-1 (T45N, R2E)

This corner is being perpetuated as part of the Chippewa County Remonumentation Program.

Found a 4" diameter concrete monument approximately 1 foot north of centerline of east-west gravel road (12 Mile Road), approximately 4 feet east of the centerline of a ditch to the north. Monument is 33 feet south of remains of a right-of-way fence on the north side of 12 Mile Road. Monument is 5 inches below road surface and contains pieces of thin wire, which is consistent with other monuments found throughout Chippewa County. Accepted corner as found and established four witness objects. THE EANY COOPING CALLER ENV COCH
