

1840 - Original corner established by Austin Burt. Witnesses: Tamarack 8, S47°W 24 links - Spruce 9, N844°W (?) 23 links.

1936 - GLO Dedpendent Resurvey of T46N, R6W. Corner position determined from the remains of an original bearing tree, a dead tamarack, 20" diameter, with original blaze and scribe marks, S47°W 24 links. Set an iron post, 3 feet long, 1 inch diameter, embedded in a concrete monument, 2 feet long, 6 inches in diameter, 30 inches in the ground, with a stamped brass cap. New witnesses:

3" Poplar, N28°E 45 links 8" Spruce, S031/2°E 126 links

10" Cedar, S821/4°W 57 links 8" Cedar, N281/4°W 53 links

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

This comer is being perpetuated as part of the Chippewa County Remonumentation Program. Found a concrete monument with a stamped brass cap as described in the above mentioned 1936 GLO Dependent Resurvey notes. Found no evidence of any of the previous bearing trees. Accepted corner as found.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Found a 6" diameter concrete monument with a stamped brass cap at the corner location. Placed a new cedar post next to the found monument.
