



B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

This corner is being perpetuated as part of the Chippewa County Remonumentation Program. Found a 2" iron pipe with a stamped brass cap as described in the above mentioned GLO Dependent Resurvey. None of the previous record bearing trees remain. A 14" hemlock with an aluminum tag stamped "78 lks" was found S82°E 51.7 feet (78.3 links) from the found pipe.
