

5. Private Claims

I, Keith R. Waters, in a field survey on November 22, 1999, do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and /or that the corner points mentioned in lines 3, 4 and 5 above re in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as expressed below:

A. Description of original monument and accessories and/or subsequent restoration:



J-11 1/4 Corner Common to Sections 26 & 35, T46N, R7W

1850 - Original corner established by Wells Burt, a beech post. Witnesses: Sugar 18, N75°E 25 links - Sugar 18, S60°W 33 links.

1922 - Chippewa County Surveyor's notes make reference to measuring north from the south ¼ corner of Section 26.

1999 – Keith R. Waters, P.S. 33142, Certificate of Survey, Liber 777, Page 147, Chippewa County Records. Corner shown as a found railroad spike. Witnesses: er wellen er

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

邓州高 This corner is being perpetuated as part of the Chippewa County Remonumentation Program. Found a railroad spike 1.8 feet west of the centerline of a north-south bituminous road (South Hulbert Road) and all of the record witness objects as called for in the above mentioned Certificate of Survey. The railroad spike was set by Eino Sainio, P.S. 7873, as a perpetuation of the position of a previously located iron which was destroyed by road construction. Accepted corner as found and replaced the found railroad spike with a 3/2" rebar and aluminum cap in a monument box.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Placed a ¾" x 24" rebar with a stamped aluminum Chippewa County Remonumentation cap in a monument box at the corner location, replacing a found railroad spike. Corner falls 1.8 feet west of the centerline of a north-south bituminous road (South Hulbert Road).
