A-2 (T46N, R1E)

This corner is being re-established as part of the Chippewa County Remonumentation Program.

Found no evidence of corner or its accessories. Re-established corner on line between Section corners 2655.98 feet north and 2655.98 feet south. Corner is on line with recorded corners at the center of Section 6 and the East 1/4corner of Section 6, T46N, R1E. Corner falls on the south side of the base of a fallen over fence post at the intersection of old fences north, south, east and west.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

A-2 (T46N, R1E)

Corner is a 3/4" x 24" rebar with a  $3\frac{1}{4}$ " aluminum Chippewa County Remonumentation cap on the south side of the base of a fence post at intersection of fences north, south, east, and west. Witnesses:
