MIND NOMENTALINI 1901 County Surveyor notes indicate corner was in place but gave no description.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

This corner is being perpetuated as part of the Chippewa County Remonumentation Program.

Found no evidence of original corner position or subsequent restoration. Placed a 3/4" x 24" iron pin on line between the Northwest and Northeast corners of Section 23 and on the extension of an old fence line to the South. This position also checks with fence on East line of one acre parcel in the Northwest corner of the Northeast 1/4 of Section 23 and with the East 1/16th line fences in Sections 14 and 23.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner: (J-7) Corner is a 3/4" x 24" iron pin with plastic remonumentation cap 1.8 feet North of centerline of 9 Mile Road.
