

5. Private Claims

I, William L. Karr, in a field survey on October 30, 1996, do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and /or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as expressed below:

NOTE: Not more than 2 corners, all in the same town and range, may be recorded on this certificate.



A. Description of original monument and accessories and/or subsequent restoration:

(J-9) 1/4 Corner Common to Sections 23 & 26, T. 46 N., R. 1 E.

J.H. Mullett used a 6" tamarack for the 1/4 section post.

- 1902 F.H. Brown in records in County Surveyors Office for a survey in section 23 shows the mile as 5254' and evenly divided.
- 1907 F.H. Brown in records in County Surveyors Office for a survey in section 26 shows the mile the same as in 1902.
- R. Bischer, PS 22428, in a survey in section 26 shows the South and Center 1/4 corners of the section. Survey 1993 recorded in Liber 651, Page 124, Chippewa County Records.
- 1995 W.L. Karr, PS 27450, Northwoods Land Surveying Job 163-347. Reestablished the North 1/4 corner section 26 at intersection of North-South 1/4 line from Bischer survey and East-West section line.
- L.R. Rogers, PS 29251, Northwoods Land Surveying Job 3008-00, shows 1/4 corner position based on previous 1995 Bischer survey.
- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(J-9) 1/4 Corner Common to Sections 23 & 26, T. 46 N., R. 1 E.

This corner is being perpetuated as part of the Chippewa County Remonumentation Program.

Found spike in centerline East-West gravel road at position shown in 1995 surveys. Spike falls on the range fence line to the North and 6.6' East of an even split. Accepted spike for corner position and replaced with 3/4" iron.
