

5. Private Claims

I, William L. Karr, in a field survey on December 3, 1996, do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and /or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law, established, re-established, monumented, recovered, found as expressed below:

Not more than 2 corners, all in the same town and range, may be recorded on this certificate.

A. Description of original monument and accessories and/or subsequent restoration:



(M-10) 1/4 Corner Common to Section 25, T. 46 N., R. 1 E., and Section 30, T. 46 N., R. 2 E.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(M-10) 1/4 Corner Common to Section 25, T. 46 N., R. 1 E., and Section 30, T. 46 N., R. 2 E. This corner is being reestablished as part of the Chippewa County Remonumentation Program.

Could find no evidence of original survey or subsequent perpetuation of the corner position.

WALLES OF THE STATE OF THE STAT Supervisors Plat No. 1 of Bruce Township, Liber 7, Page 35, Chippewa County Plats, monumented the North 1/16th corner between sections 25 and 30. The North 1/4 mile is shown as 1329.1 on the plat.

The total mile measures 5316.36'. The Southwest corner of the plat is on the section line and at the proper distance from the section corner 19, 30, 24 & 25. Reestablished the 1/4 corner mid-way and on-line between the section corners to the North and the South.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(M-10) 1/4 Corner Common to Section 25, T. 46 N., R. 1 E., and Section 30, T. 46 N., R. 2 E.

Corner is a 3/4" x 24" re-rod with plastic Chippewa County Remonumentation Cap. Corner falls at the Northerly edge of a small area of dry ground surrounded by alder and submerged land. Corner is set 0.3' above grade.
