B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

DVOMEN (A-5) This corner is being re-established as part of the Chippewa County Remonumentation program.

Found no evidence of original corner. Re-constructed corner position 33.00' West of a North-South right-of-way fence for Townline Road and 33.00' North of the Southerly R.O.W. fence for an old grade going East between Sections 7 & 18. From the newly re-constructed corner there is an East-West 1/4 line fence in Section 18, 2653.44' to the South and East-West 1/4 line fences to the North which measure 2653.95'.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Corner is a 3/4"x 24" iron with plastic "Chippewa County Remonumentation" cap on the approximate centerline of Townline Road (gravel) and 23' North of the centerline of Forrest Side Road to the West.
